A couple of larger fiber glass and epoxy repairs needed: Dave and Brendan will help Dwayne and the club will reimburse any expenses incurred.

Swift Bearing Seal repair needed-hole where the handle is.

Summary: Rest of boats in reasonable shape. Dwayne is pro-active in keeping up with repairs.
