- 1. 7:05pm: Call to Order
- 2. Approval of agenda. Approved.
- 3. Adoption of March 16, 2015 minutes: Spelling of Russell's name and of buoy need correcting. Minutes approved.
- 4. President's Report: Dwayne

6. Treasurer: Kathleen

Current assets – Admin \$1159.21 – Marathon \$3,498.07 – Recreation \$43,377.46 – Rec Self Insurance \$4,500.00. A year-to-date breakdown of debits and credits for each of the above was handed out. Discussion re Recreation capital purchase decisions, Brendan will look at recreation boat sales and purchase needs.

Administration fees for this year are higher than projected due to the added yearly cost of dock insertion and removal.

Therefore:

Motion: Catherine Trask moves \$2,000 be borrowed from Recreation funds and put into Administration. Brendan Haynes seconds. Unanimous

Kate passes out The Saskatoon Canoe Club's financial statement as prepared by HNG Accounting Group.

Motion: Dwayne Surdu-Miller moves we approve the accountant's financial report. Catherine Trask seconds. Unanimous.

Nordic Club: The Saskatoon Nordic Ski Club vacated our premises March 31, 2015. The documents for changes to the Boathouse rental agreement have been signed by all rental parties and submitted to the City of Saskatoon. Money owing for the rental change is to be assessed.

<u>Docks</u>: We are unsure of the cost of the docks. We must beware of being obliged to spend money we do not believe necessary. We need an *explicit written inventory* of everything our \$1,800 was spent on. Brendan is in contact with Russell, the Vice Commodore.

Sale- Blue Nova craft-not used.

<u>Trips</u>: No activities or trips planned so far. We will try to get people to organize trips. <u>Space</u>: As of April 1st the space is all ours. We must decide how to use the extra space.

<u>Events</u>: Coaching clinic this weekend in Regina; Paddle Symposium next weekend, April 25th; Cook's Creek, Manitoba, May 25th; Ski to Sea and Clinton end of May; and Lumsden Sask. race June.

<u>Equipment purchases</u>: a) foot braces: We need 5 or 6. Catherine will purchase them in Minnesota, paying in US cash from her own funds, and later be reimbursed by the club.
