Request For Funding

The Saskatoon Canoe Club is requesting funding for three distinct programs as listed below:

Coach/Director

The Saskatoon Canoe Club requests funding for the costs involved in providing the following activities for the members of the Saskatoon Canoe Club:

- 1. Organization and execution of learn to paddle sessions for the general membership
- 2. organization and execution of skill development clinics and lessons for the general membership
- 3. organization and execution of races for race participants
- 4. other duties as assigned by the SCC Executive.

It is anticipated that the total amount of funding required to provide these services to the general membership will be \$10000.00. The funds will primarily be used for compensation of the individual(s) providing the services, e.g. coaches and instructors. Some of this money will be provided by the SCC but the bulk of it, estimated at

\$7500.00, needs to be funded externally and hence this application for funding from CKS.

Youth Canoeing Program

The Saskatoon Canoe club requests funding for the costs involved in providing a series of lessons to develop canoeing interest and participation with youths aged 14 to 18 years of age. The lessons will consist of a number of skills and practice sessions culminating in an overnight trip on moving water. It is anticipated that the costs of this program will be \$3000.00 per series. Currently the plan is provide two series of lessons for a total cost of \$6000.00 Some of this money will be provided by the participants and the SCC but funding is requested from CKS for a total of \$4000.00 or \$2000 for each series.
