Trailer replacement:

Discussion: Does it need a trailer box? A 1200lb. dry trailer is too heavy for regular mid-size vehicle to pull, and gear in the trailer makes it heavier; wind can push you into the ditch. Alternative to trailer: cars could carry canoes. Conclusion: we need a trailer for club trips of 4-14 people.

Define <u>characteristics</u> our trailer needs: 14 inch wheels, weight under 700 lb. empty (including trees and storage), built to hold 6 canoes or 12 kayaks, and have a lighting package and full sized spare. Food barrels do NOT go in the box-therefore box size should be approximately 72 inches long and 12 inches deep. We can build the box ourselves if necessary.

Conclusion: Graham will get written quotes from Fresh Air and Eb's for the next meeting.

Boat House Space: Wildwood equipment will stay in the Wildwood container. But Kinsmen equipment will be coming back to our boat house. Some may possibly go into a second container at Wildwood.

Ordered Equipment: Dave, Kendra and Bryan on committee. Dave will follow up on ordered equipment.

Boat house orientation, welcome letter and brochure: Richard wants us to look over these. Nothing will be e-mailed until finalized by discussion with Richard.

Rent for Boat house: \$1,877.33 owing.

New Business:

New trailer: When it comes we will need to compile rules for maintenance for safety and servicing. (Suggestion: it be serviced every April.)

Clyde-needs an orientation package. He will contact those giving lessons.
