## Reports

## Membership-Richard

# Financial-Randy

- The presented balance sheet includes only cash assets. The value of the inventory has yet to be added in.
- Randy has accounted for 6 free memberships with Richard's help.
- He's shown expenses to Rec. cost \$210.00 approximately to give free memberships.
- There's nothing from CKS on MAP grants yet.
- Approximately \$10,000 will go to CKS for membership.
- \$607 is owed to Dave for throw bags.
- Action: Randy will phone the person who gave the NSF cheque.
- Still waiting for information from Trevor on the Saskatoon Race.

Summary: We're still in a good financial position.

# Publicity-Bryan and Karrie absent

## Marathon-Hanna

- Saskatchewan had several members achieve gold at the Nationals: Ross Phillips, Cathy Rae and Ann Popoff. Dave will get Cathy to put this on the club facebook page. Also Randy and Nathan were first in the La Ronge Nut Point Challenge, and Ann and Randy got 2<sup>nd</sup> in the Stanley Mission race.

Marathon Financial Report to Treasurer: Trevor has not handed this to Randy.

Cable Lock installation: The Swift Kayak is locked down.

<u>Action</u>: Dave will send a note to Jim. There is a second boat on the repair rack needing repairs.

Addition of whitewater and water flow links to website: This has been added.

Club Insurance Policy:

<u>Action</u>: Dave Peters, Randy Chapman and Trevor Robinson will present recommendations at the AGM for club equipment insurance.

Medical Kit contents: still outstanding.

Recreation Lesson Invoice changes: Randy talked to Brian who will talk to Jeff.

Actions since last meeting

Resignation of Mark as Recreation Director

Dave: The recreation director and equipment manager have knowledge of who is leading trips.

All lessons have now been given.

The director made decisions on lessons and free memberships. We can possibly limp along without a director till the end of the year. Discussion as to whether we need a social director. Current status: no president, no recreation director, and no social director. Action: We need to look for people who can fill these positions.

Conclusion: We can get by without a recreation or social director. We should plan to fill the recreation position at the AGM in November.

The open house is a good way to get memberships.

# CKS Information-Randy and Richard

<u>Action</u>: Richard will fill it out and sent it to Randy. We're doing what they ask of us. <u>Action</u>: Richard will provide David with the required changes to information contained in the provincial membership summary report.

Trailer Repair: Discussion to decide what we need to do concerning Vern Kiss's request to be reimbursed for \$682.16. However we have no receipts yet so no money can be sent until we receive documentation. The axle was bent, and the tree had been repaired in the past. Dave: We should recompense him for expenses upon receipts being provided. Vern has been given the form to fill out. We can possibly offer the trailer to the membership.

Motion: Dave moves we reimburse any receipt-supported claims made by Vern Kiss with respect to repair and recovery of the trailer. Randy seconds. Unanimous approval.

Note: The group took a solo boat (one not to be rented to private individuals) without permission.

Trailer rental-\$225-he made repairs to make the trailer road worthy

Boat rental: \$270 (\$30/day for 9 days) Give him back his damage deposit.

Motion: Richard moves the club destroy the damage deposit cheque of \$60.00. Dave seconds. Unanimous approval.

Summary of discussion: the plan is to offset the claim made by Vern by the amount he owes for trailer rental (\$225) and boat rental (\$270-9 days at \$30/day).

Table: discussion of where the new trailer can travel (ie. no gravel roads?) for when we get the new trailer.
