- 1 Opening Remarks from Cathy Cathy expects that we interact with respect, wait our turn and allow all members to participate equally. This will ensure that the meeting runs smoothly and as quickly as possible.
- 2 Adoption of Agenda Richard adds that we discuss the Facebook page as Russell is an outgoing Executive.

Agenda is adopted as amended.

3 Old Business – Dave takes Chair of the Meeting.

Minutes from Tuesday May 4th, Richard would like his name removed from the discussion about the PFDs.

Dave Moves (Graham Seconds) to adopt the amended minutes from the 4 May 2010 Meeting . Motion passes.

Moving forward with the PFDs. Dave presents three options as suggested by the executive in emails collected in the past week. Distributes the summary of this breakdown to the meeting members. (attached)

Wes would like to add a 4th option to include: Rejecting Jim McDonalds offer, selling the PFDs on E-Bay where we could potentially recoup much of the cost, money to be put toward new Canadian approved PFDs.

Debate on the PFD options. Executive express their individual concerns and the option they would prefer.

Dave Moves (Graham Seconds) to accept Jim McDonalds offer. Vote on the Motion.

6 in Favour, 3 opposed. Motion Passes.

Wes Deptuch takes this opportunity to resign his position as Recreation Director. (Attached)

Bob Farthing leaves the meeting at this time. Resignation received by email (Attached)

Dave Moves (Graham Seconds) not to take legal action through small claims court or Better Business Bureau. Debate on motion.

Bryan motions to split the motion into two phrases. Phrase one to read: Not to take legal action through small claims court. Phrase two to add to phrase one: or Better Business Bureau.

Vote on Phrase 1. Passed.

Vote on Phrase 2. Passed.

Executive are reminded that if they choose to pursue action through either of these venues, they must not do so as an Executive member, they must do so as a private citizen.

Dave speaks to the next course of action. He will act as the single voice to Canada West Paddles Sports. He will give the PFDs back, a check for 50% deposit and ask for a timeline. A check for the 50% of the outstanding order will also be given to Canada West Paddle Sports.

Dave gives meeting chair back to Cathy.

- A) Finances All bills are up to date as of today. Membership deposits have been made on most, but not all due to time constraints. Tax info yet to be done. Everything is ready to go to Randy's brother for review. Kendra expressed concern about the Tax form and may require help with it.

Bryan motions (Dave Seconds) that all future door code changes be made by the boathouse security manager no later than one week after the fiscal year start. Vote on the Motion. Passed.

Randy has expressed interest in taking over the treasury and she will contact him about transfer of the Treasury duties. Kendra to stay on as signing authority. She will take over the Equipment Manager duties at this point.

Cathy will take over the Newsletter Editor duties.

Kendra reads a prepared statement as follows:

"Speaking to the agenda item, Executive Conduct and Member Representation

Executive members, since joining this group in January of this year, there have been multiple cases of inappropriate behaviour, unethical conduct, and poor representation of our large membership by some members of this executive. Some examples of this include:

- -emotional outbursts & talking out of turn at meetings
- -members displaying poor judgement with regard for how to approach a matter and when to do it. (Ie: how the underlying issue was handled on our club's most important day of the year, our Open House)
- -disregard for other people's opinions and comments
- -negative bias towards new leadership with a different vision.
- -inappropriate use of e-mail
- -anonymous threatening e-mail that implicates the entire SCC executive for events occurring over the past week.

It is my opinion that those members that have displayed the aforementioned examples of misconduct take responsibility for their actions."

Kendra motions (Graham Seconds) to adopt CKS policy regarding membership code of conduct.

CKS policy reads: "Membership Discipline

The voting members shall have the power to discipline or terminate a member for failure to comply with the constitution or bylaws of the organization, for conduct unbecoming as a member or for such other just cause as provided for by the adoption of a resolution at a special meeting of the organization."

Richard moves (Bryan Seconds) that SCC "Code of Conduct" be deferred to a committee, membership to be determined at next meeting. Vote on the Motion. Passed.

To be uncertain is to be uncomfortable, but to be certain is to be ridiculous.

The attached spreadsheet (and the pfd in case you don't have excel handy with the summary below) describes the numbers as I see them after having talked to Jim MacDonald this week.

The first table is the existing order, consisting of the cost + shipping + GST = total or 1290 + 155 + 72.25 = 1517.25

The second table is the return of the PFDs less shipping and restocking fees = credit or 1290 - 300 - 275 = 715. I did not include the GST in the refund as I am also not including it in the cost of the replacement PFDs so they cancel out.

The third table is the cost of the replacement PFDs + shipping + GST on the shipping = total 1290 + 100 + 5 = 1395.00. Then the credit of 715 is applied for an amount owing of 1395.00 - 715 = \$680.00.

Jim stipulated a 50% deposit prior to order so that is shown as well - 340.00.

The outstanding order table lists the equipment and their costs plus an estimated shipping and GST for a total of 4084.50.

The 50% deposit of this is also shown, 2042.25.

If this offer is accepted by the executive tomorrow, I will contact Jim MacDonald and provide him with the amounts above along for which I will receive a receipt indicating that the SCC has paid 50% of a total amount with the remainder due on delivery. As the shipping costs are estimates I plan to offer him two choices, either bill us the actuals (for which we will require a copy of the shipping invoice from the shipping company) or he can fix the shipping values at the estimated amounts. In either case this will noted on the receipt so there is no confusion later on.

- 1. Accept the conditions as outlined. Cost to club is an \$680.00 more, PFDs are replaced in time it takes to get them shipped, estimated at 1 week.
- 2. Decline the offer and buy PFDs from another source. Cost to the club is approx \$1500.00 depending an replacement PFDs. PFDs are replaced in time it takes to get them quoted, ordered and shipped estimate 1-2 weeks.
- 3. Take legal action to recover full cost of PFDs. Same time and financial position as option 2 as the time required to get resolution is likely much greater than 2 weeks, even if small claims court is the avenue selected. Court costs to file a claim in small claims count would be \$20.00 in our case plus costs for subpoenaing witnesses, process server and so on. Regular court who knows

I am going to recommend option 1 even though the cost to the club is higher than I had originally expected. I have no desire to pursue the legal both because I don't know that judgment would go against Jimmy and because I think impact on the morale of the club executive would be very negative.



Boathouse Information 2010

BOATHOUSE ETIQUETTE

The Saskatoon Canoe Club (SCC) is one of several clubs that operate out of the Victoria Boathouse. The Saskatoon Rowing Club uses 2 bays on the north side of the building and the Training Centre, while the Saskatoon Racing Canoe Club uses 3 bays on the south side. The SCC shares the lease of Bay #4 with the Saskatoon Nordic Ski Club, which stores their track setting equipment in the back of the bay.

The SCC does not have regular open hours; members come and go at their leisure. From May to August, an executive member will be at the boathouse from 7 to 7:30pm on Tuesday evenings so that memberships can be purchased and boathouse orientations provided.

After purchasing a membership and receiving an orientation, you will be provided with the door code. Please ensure that the door code remains with current members only. The nearest washroom is located on the south side of the boathouse, but it is locked in the evenings.

Vehicle access to the water is reserved for loading and unloading boats - please park in the parking lot when just coming down to paddle. Due to space limitations, bikes should be locked up at the bike

> racks located on the south side of the building.



belonging Recreation are stored on the north side of the bay (on the right as you open

the door, while Marathon boats are stored on the south side of the bay (on the left as you open the door).

If you are a Recreation member, you can only use Recreation boats. If you are a Marathon member, you can only use Marathon equipment. However, if you are a member of both divisions, you can use all of the boats. *New Marathon members are required to participate in a Group Paddle prior to using Marathon

equipment their contact marathon@saskatooncanoeclub.org for times.

Kayaks are to be stored on the 3 bottom racks closest to the door, while solo boats are stored on the bottom rack in the back of the bay. This is done so that members coming down by themselves can access the boats they wish.

PFDs are hung on the rolling rack, while canoe paddles are kept in the bins near the back, with the grips up. Kayak paddles are hung with all the

necessary safety equipment on hooks between the boat racks.

Canoes are available on a first come, first served basis. Before taking a boat out on the river, first check the whiteboard mounted on the wall on the right as you walk in to see that the boat you are interested in using is not reserved for a trip on that day. When taking a canoe out on the river, write your last name, the boat number, when you left, and when you expect to return on the whiteboard. In the event of an emergency, this is the manner in which we will be able to inform the necessary personnel. If the boat is to be taken overnight or away from the boathouse on a vehicle, it must be booked in advance with the Equipment Manager; a deposit will serve as confirmation of the booking.

When returning equipment, please ensure that it is clean. A hose is located just inside the bay door and sponges are to be used to wipe down boats. If equipment needs repair, contact Equipment Manager at mainenance@saskatooncanoeclub.org

Club Trips

If equipment is going to be used overnight, it needs to be booked in advance with the Equipment Manager. Club Trip leaders can book equipment for trips at anytime, however it is advisable that the booking is made at least 2 weeks in advance of the start date of the trip. For private trips, equipment can only be booked a maximum of 14 days in advance of the start date of the trip.

Leading an overnight Club Trip is encouraged; the leader does not pay for boat rental and earns a free membership the following year. Sunday Paddles too, lead 2 Sunday paddles, and get the same free membership. Club trips have priority choice of equipment over private trips. The Trip leader will book boats on behalf of Club members. To qualify as a Club Trip, the event must: be advertised in SCC publications (website bulletin board; newsletter; and/or email (contact the membership director (membership@saskatooncanoeclub.org) to have your trip info sent to the entire membership); have at least 2 weeks notice given; and have only SCC



boat rental \$5/person/day, while there is no charge for use of a canoe trailer. It is important to note that these guidelines

heavily on the honor system. Failure to follow these guidelines will only result in the need for greater restrictions.

Private Trips

For private trips, the only canoes that can be rented are the:

- #5 Old Town Tripper
- #3 Clipper Prospector
- #15 Mad River Horizon

There are no restrictions on which kayaks can be rented. Only one (1) boat can be rented per adult member. A \$60 damage deposit cheque is required to ensure the safe return of the boats and miscellaneous equipment (PFDs, paddles, throw bags, etc.) This cheque will be destroyed upon safe return all equipment. Boat rental fees are \$30/boat/day, while trailer rental fees are \$25/day.
